 <sup>1)</sup> **Roaming: GigaData 5 & GigaData 25:** included data volume can be used charge free within Germany and the listed EU countries. **GigaData Max:** The unlimited data usage is only valid within Germany. The GigaData Max, data usage is according to the included EU budget from the original tariff. The included EU budget can be found in the MyTKS App. The shown data volume is per billing cycle & will be calculated from the use in the EU plus the usage over the easyTravel option. Exceeding the included volume (EU & easyTravel option) will be charged at € 0.0018 per MB (€ 1.80 per GB). **TKS 5G Data Tariffs:** Included roaming connections do not apply to international waters (e.g.: ferry, boat trips, etc.) or service numbers. The EU Roaming is only valid in TKS easyMobile / Vodafone (partner) networks. For all countries outside of the EU refer to TKS easyMobile Roaming tariff and option rate sheets.

<b><sup>2)</sup> TKS easyMobile Tariff Remarks</b>	
<b>Contract conclusions:</b>	A maximum of three TKS easyMobile contracts can only be issued to one customer and can only be made in the military sponsor's name.
<b>Data volume / transmission speed:</b>	The flat rate is only valid over the APN: web.vodafone.de. TKS reserves the right to automatically disconnect the connection after 24 hours of continuous use. VOIP, tethering and peer-to-peer are permitted. WiFi-Hotspot and Router usage is only permitted for one's own private use. A transmission speed of up to 1 Gbps download / 100 Mbps upload is the upper limit and can't be guaranteed. The actual utilization speed depends amongst other things on the structural characteristics of buildings in the vicinity and the number of mobile devices that are connected to a mobile radio cell at the same time. Also, a compatible mobile device is required for the usage of the fast 5G network. A speed limitation of 32 kbps applies after exceeding the included data volume.
<b>Rollover monthly data:</b>	Keeps the unused data volume until the end of the following billing cycle. The current data volume will always be used before the rollover data goes into effect. The rollover monthly data may also be used within EU countries.
<b>Vodafone hotspots:</b>	Free Vodafone Hotspot. TKS provides monthly a Hotspot access code voucher. This service starts with the first invoice and thereafter on every monthly invoice.
<b>Billing:</b>	The monthly package price will be charged in advance. On the first invoice there will be the charges for the activation fee and a prorated price for the first month depending on when the service was started plus the monthly package price for one month in advance. The included budgets and flat rates are always valid for one billing cycle and will be reset at the end of the billing cycle (not the end of the calendar month). The billing cycle is from the 6 <sup>th</sup> of the month to the 5 <sup>th</sup> of the following month. Important: With the contract conclusion the budgets and flat rates will be prorated according to remaining billing cycle time frame.
<b>Minimum contract duration:</b>	Cancellations are only valid to the end of the following month.
